Do Not Enter an NBL Division unless you are of blackbelt skill level. All blackbelt and under blackbelt players must enter divisions based upon the age they were on January 1, 2008 at 12:00AM. See exceptions - Rules at a Glance in back of brochure under **FORMS 6**, or SKITA rulebook V.B.4. Coaches passes allowed for Sparring only and ONLY when your player is "on deck" or "UP". VIP Spectator allows you to sit ringside for all eliminations and Finals.
